<u>Global Distribution Services</u>: standard limit of liability of fifty cents (\$0.50 USD) per pound up to a maximum of fifty U.S. dollars (\$50.00 USD) per lot or the actual value of each piece of any Goods lost, damaged or destroyed, whichever is less.

International Freight/Air Services:

Standard limit of liability of twenty-six Special Drawing Rights (26 SDRs) per kilo.

International Freight/Ocean and Order Management Services:

United States: standard limit of liability of five hundred U.S. dollars (\$500.00 USD) per customary shipping unit (CSU) for Goods imported to or exported from the USA.

Signers of the Hague-Visby Convention: standard limit of the greater of 2 SDR/kg or 666.66 SDR per CSU for Goods imported to or exported from countries which have signed the Hague-Visby Convention.

All others: The lesser of five hundred U.S. dollars (\$500.00 USD) per customary shipping unit (CSU) or US\$2 per kilo of the gross weight of the Goods.

North America Transportation Services:

(United States): standard limit of liability of fifty cents (\$0.50 USD) per pound, or the actual value of each piece of any Goods lost, damaged, destroyed, or delayed, whichever is less.

(**Mexico**): standard limit of liability of 15 days of the current daily value of the Unit of Measure and Update as published in the Official Gazette of the Federation (Diario Oficial de la Federación) each year by the Mexican National Institute of Statistics and Geography (Instituto Nacional de Estadística y Geografía) per ton of Goods or the proportional part of the ton of Goods that corresponds to Goods of lesser weight.

(**Canada**): standard limit of liability of four dollars and forty-one cents (\$4.41 CD) per kilogram computed on the total weight of the shipment.

Europe Transportation Services:

Local Trucking: Standard limit of liability that is legally required by the local national regulations and laws.

European Transportation Services: Cross Border Trucking: standard limit of liability under the Convention for the Contract of International Carriage of Goods by Road ("CMR") of 8.33 SDR per kilo, or the actual value of each piece of any Goods lost, damaged, destroyed, or delayed, whichever is less.

Africa/Middle East/Indian Subcontinent Transportation Services:

Local Trucking: standard limit of liability of fifty U.S dollars (\$50.00 USD) per pound up to a maximum of five thousand U.S. dollars (\$5,000.00 USD) per shipment, or the actual value of each piece of any Goods lost, damaged, destroyed, or delayed, whichever is less.

OR

Standard limit of liability that is legally required by the local national regulations and laws.

Asia Transportation Services:

Local Trucking: standard limit of liability of one U.S dollar (\$1.00 USD) per kilogram up to a maximum of fifty U.S. dollars (\$50.00 USD) per lot, or the actual value of each piece of any Goods lost, damaged, destroyed, or delayed, whichever is less.

OR

Standard limit of liability that is legally required by the local national regulations and laws.

Transportation Services - All other locations:

Local Trucking: Standard limit of liability that is legally required by the local national regulations and laws.

Project & Energy Services

Domestic Services: the lesser of the actual cost to repair or replace the Goods (referred to as "Project Cargoes" in customer terms & conditions) or ten cents (\$0.10 USD) per pound.

International Ocean and Order Management Services: standard limit of liability of five hundred U.S. dollars (\$500.00 USD) per customary shipping unit (CSU).

International Air Services: standard limit of liability of twenty-two Special Drawing Rights (22 SDRs) per kilo.
